1B: RELATIONSHIP WITH SYDNEY SECONDARY COLLEGE

Councillors will be aware that Leichhardt Council has had a strong ongoing relationship with the Sydney Secondary College, Leichhardt Campus over the years.

On 8 September 2005, I met with representatives of the Sydney Secondary College, Leichhardt Campus to discuss a number of issues that the College have been concerned about for some time and to seek assistance to resolve these issues.

One particular issue of concern was the ongoing maintenance of the Basketball Court on College grounds. While the school is keen to encourage community use of the Court, it is concerned about the ongoing problems of damage and graffiti to the Court and surrounding fence. They have requested that an arrangement be made where the Council and College jointly manages the facility and assists with some of the costs of maintaining the Court.

The College also raised the ongoing issue of proposed School oval earmarked for the old Bus Depot sight across the road from the College. The College is concerned that the progress for the approval and construction of the School Oval is taking much longer than hoped and that the School desperately needs open recreational space for the students to use.

Other issues of concern are traffic Problems in Derbyshire Street particularly difficulties caused by illegal parking in Derbyshire Street and the proposed school oval planned for the old Bus Depot site.

- ii. Clause 2.2 is deleted and replaced by the following:
 - "2.2 Subject to clause 2.3, Council grants to Tigers:
 - a licence to enter upon and use Leichhardt Oval number 2 on no more than 4 days per calendar week for a total maximum of 20 hours per calendar week; and
 - a licence to enter upon and use Leichhardt Oval number 3 on no more than 4 days per calendar week for a total maximum of 20 hours per calendar week.

A "calendar week" is from Monday to the following Sunday.

- 2.3 Tigers must reserve the Leichhardt Ovals through Council's normal booking system when it wishes to use the Leichhardt Ovals number 2 and 3 in accordance with the licences granted in clause 2.2 and provided further that:
 - a) Tigers is not entitled to reserve or use a Leichhardt Oval on both a Saturday and the immediately following Sunday, but is only entitled to reserve and use each Leichhardt Oval on one day only of each weekend.

- b) Tigers is not entitled to reserve or use a Leichhardt Oval on days and at times when it is required by Balmain Tigers Rugby League Football Club;

- d) Tigers is not entitled to reserve or use a Leichhardt Oval on days and at times when Council has reserved it for community events including but not limited to community fun runs:
- Tigers must not reserve or use the Leichhardt Ovals e) later than 10:00 pm on any night."
- Clauses 13.1, 13.2 and 13.3 are amended by changing "Ovals" to iii. "Oval" and the following is added as clause 13.4:
 - "13.4 The parties agree that other groups and persons may use the Leichhardt Ovals at the discretion of and by bookings made through Council."
