Local Government Excellence Awards

On 7 April 2016, Ashfield Council received the 'Excellence in Age-Friendly Communities' Award from LG Professionals' annual LG Awards. The award recognises the work achieved by Council in a suite of programs that have improved the accessibility and safety for pedestrians of all ages, including:

- Accelerated Footpath Program, which delivered ten years' worth of new footpath across the LGA, in under 18 months and this was coupled with the replacement of 1160m of kerb and gutter;
- Grass verge conversion initiative, which installed 2,630m² of grass verge along footpaths, improving the pedestrian experience of our footpath network;
- Bus stop accessibility project, which upgraded 44 bus stops to improve their accessibility for low mobility or vision-impaired residents;
- Access ramp improvement initiative, upgraded 167 ramps to improve pram, wheel chair and pedestrian access and safety when crossing local roads.

In addition to the delivery of capital works, the Award recognises the outcomes of internal collaboration, mentoring, leadership and innovation in procurement, design and contract management led by Council staff.

WestConnex - Urban Design Review Panel

Council continues to receive ongoing requests for representatives to attend meetings linked to the WestConnex project. The latest request, received yesterday (11 April 2016), is for an Ashfield Council representative to attend an Urban Design Review Panel (UDRP) meeting scheduled for this Friday, 15 April 2016.

The establishment of the UDRP is a requirement of the development consent issued for the M4 East WestConnex project by the State Government last February. The Panel's role is to provide advice in relation to architecture, heritage values, urban and landscape design and artistic aspects of the project. It is intended to meet at least four times per year. The first meeting will include a presentation from the contractor and their consultants and take place at the SMC offices in George Street, Sydney.

As has been the case with similar requests in the past, the notice provided for such meetings is totally inadequate. The Council needs to have an ongoing role with construction of the project but the engagement strategy employed by the Sydney Motorway Corporation (SMC) with key stakeholders to date needs serious review. Council needs to determine its representative to attend this and other planned meetings scheduled in coming months.

It should be noted that officers have arranged for representatives from the SMC to brief Councillors at next week's Planning & Environmental Services Committee meeting (19 April 2016) on the design aspects of the project.
